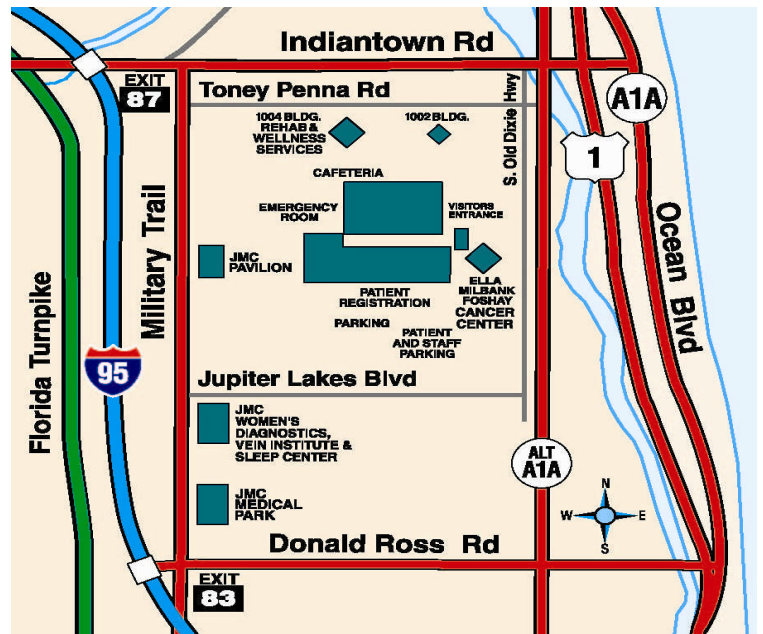
Directions:

From Florida's Turnpike or Interstate 95, exit at Indiantown Road-East. Head East to Military Trail (approx. 3 miles). Turn right (south) at Military Trail to Jupiter Lakes Blvd. Turn left (east) at Jupiter Lakes Blvd. Follow Jupiter Lakes Blvd. And Jupiter Medical Center will be on your left. This is the South entrance to the Medical Center.

From Route 1 in Jupiter head west on Indiantown Road to Alt. A1A. Turn left on Alt. A1A heading south, to Toney Penna Road. Turn right heading west on Toney Penna and cross over the railroad tracks. Take your immediate left, you will be on South Old Dixie Hwy. Jupiter Medical Center will be on your right. Turn right on Jupiter Lakes Blvd. Take your first right. This is the South entrance to the Medical Center.

Complimentary valet parking is available for your convenience.

Enter through the South entrance off of Jupiter Lakes Blvd. Once inside the Medical Center, turn right and follow the signs to Occupations Health Services.
